NOTIFICACION POR AVISO MES DE SEPTIEMBRE DE 2018

La suscrita inspectora de policía con funciones de tránsito de Zipaquirá, procede a adelantar el proceso administrativo de notificación por aviso a los contraventores que se relacionan, de acuerdo a la orden de comparendo correspondiente, y teniendo en consideración los preceptos indicados en la Resolución número No.678 de fecha 09 de diciembre de 2016, y de conformidad con lo dispuesto en el artículo 69 de la Ley 1437 de 2011 y la Ley 1843 del 14 de julio del año 2017 procede a notificar por aviso a las personas que se relacionan en el siguiente listado de los comparendos electrónicos impuestos a través de los equipos técnicos y tecnológicos . La presente notificación se publicará en la página web y en un lugar de acceso al público de la Secretaria de Transporte y Movilidad por el término de cinco (5) días. Al día siguiente de la desfijación del presente aviso se considerará surtida la notificación y se dará inicio a los términos establecidos por el Código Nacional de Tránsito, así:

En el caso aceptar la infracción puede efectuar el pago dentro de los once (11) días hábiles siguientes a esta notificación y obtener un descuento del cincuenta por ciento (50%) o podrá cancelar el setenta y cinco (75%) del valor de la multa, si paga dentro de los veintiséis (26) días siguientes a la presente notificación, en estos casos deberá asistir obligatoriamente a un curso sobre normas de tránsito. Si está en desacuerdo con la Orden de Comparendo, podrá presentarse personalmente o por medio de Apoderado, dentro de los próximos once (11) días hábiles siguientes la presente notificación, a la Secretaría de Transporte y Movilidad de Zipaquirá, para manifestar su desacuerdo y programar audiencia pública en la que usted podrá solicitar o presentar las pruebas que considere útiles para su defensa. No obstante, si es sancionado deberá cancelar el 100% de la multa de conformidad con lo establecido en el artículo 136 del CNT. En caso de no efectuar el pago en los términos antes establecidos o no presentarse al proceso contravencional, este seguirá su curso, entendiéndose que queda vinculado al mismo, fallándose en audiencia pública y notificándose en estrados, quedando obligado a cancelar el 100% de la multa impuesta más los intereses de mora.
